Letter to Ainley

- Liz has drafted a letter requesting that Ainley examine alternatives to the single, centralized waste water treatment system for the Town of Erin.
- Liz will forward the letter to Ainley, and to the Town Clerk so that it can be circulated to Council.
- Jay will circulate it to the Public Liaison Committee.
- According to the latest update, CVC has not indicated any concerns.

Cornerstone

• Nick's presentation to council was well done and well received – it was referred to staff and Nick will answer any questions or concerns.

Nestle (Jay recused himself from the discussion)

 A draft resolution was circulated to the committee and the following refinements were suggested; that Nestle pilot a deposit system for their plastic bottles – there are precedents in a number of American states (As of October 2010 there are 11 states that have container deposit laws; California, Connecticut, Delaware, Hawaii, Iowa, Maine, Massachusetts, Michigan, New York, Oregon, Vermont.)

Motion: Be it resolved that the Town of Erin:

1. Reject the voluntary levy because water is a basic human right and should not be commodified. (Besides, local citizens in our urban centres have access to healthy, safe drinking water via taps.)

OR

2. Accept the voluntary levy on the condition that: a) Nestle initiates a pilot project in the Town of Erin requiring a 10 cent deposit on all Nestlé plastic water bottles, and offers a means to collect + recycle far more than 60% of these bottles. Several jurisdictions such as Alberta already have deposit systems for plastic bottles as well as other containers. (www.bcmb.ab.ca/refunds-recycling/refund-amounts-containers-sold-in-alberta) b) Nestle raise the levy from .50 cents to \$1.00 per 1000 litres, and the annual minimum from \$25,000 to \$50,000 c) Council shall direct funds from the levy to green initiatives in the Town. d) Nestlé bottle water from Hillsburgh in coloured glass to be able to track its lifecycle. (Alternatively, to report where its bottled water products are distributed for sale and consumption). e) Nestle offer, in its regular report to the Town, progress on addressing the 'bigger picture issues' of corporate social responsibility, and its efforts to eliminate the problem of plastic pollution in our rivers, lakes and oceans.

Moved by Liz. Seconded by Heidi. Motion carried.
