

- Reached out to Department asking for top 5 topics and are addressing them.
- Established contacts within the Building Department and have acquired a structure that's up
  for demolition on 10 Side road that will serve as a training ground for many topics involved with
  structural firefighting.
- Training topics for both stations are the same to allow members who missed their night to come to other station.
- We have developed a plan that includes the 5th training night in some months as "Joint Training" where both stations are training together on chosen topics. This will provide 6 joint training sessions between May 2<sup>nd</sup> and December 31<sup>st</sup>.
- After a long break from hands on training due to Covid -19, we have covered topics that are
  the bread and butter of the Fire Service, the Department has been challenged with serious
  motor vehicle accidents and structure fires. Our members have risen to the challenges and
  made us proud.

## **FIRE PREVENTION**

#### **Fire Inspections:**

The Chief Fire Prevention Officer completed the mandatory Fire Inspections and witnessed a timed fire drill at the vulnerable occupancies within the town. No issues or concerns were noted, all are compliant.
