5. Guest Speaker: Wellington County Councillor, Jeff Duncan

Provided overview of Wellington County's Environment & Sustainability Initiatives. \$301.4 million dollar budget. \$128.8 million in tax dollars. The initiative began in 2021 through Wellington County's directive. Town of Erin has one of the largest landfill sites. Some initiatives organized include:

- Started leaf and yard waste collection and compost bins. First collection of the year this
 month.
- Household hazardous waste collection.
- Opportunity to help with former landfill sites pollinator gardens. Budget of \$20 000 for this. Second transfer station on 8th line.
- Required third party who collects solid waste to move away from diesel and to use electric vehicles.
- \$1.4M provided by Ontario to continue Ride Well program.
- The Green Legacy plants 170 000 trees annually you can volunteer or request trees here: <u>Green Legacy Programme Planning Wellington County</u>.
- Our Impact 2020-2023 Our Food Future global meeting happening locally in June.

The Province of Ontario is taking over recycling collection in 2025. Wellington County has the opportunity to continue picking up for businesses or not. Decision will be made in the coming months. How are businesses going to take care of their recycling? Can we work with the Chamber to promote this?
